

MINUTES OF THE REGULAR MEETING OF THE SCHOOL DISTRICT OF CASSVILLE,
GRANT COUNTY, WISCONSIN: October 27, 2025

1. Call to Order
 - a. The meeting was called to order by Donald Uppena, Board President, at 6:00 p.m. in the Board Room.
