

MINUTES OF THE REGULAR MEETING OF THE SCHOOL DISTRICT OF CASSVILLE,  
GRANT COUNTY, WISCONSIN: November 18, 2025.

1. Call to Order
  - a. The meeting was called to order by Donald Adams, Board Member, at 6:00 p.m. in the Board Room. Roll call of attendance: Holly Mumm, Donald Adams, Jayson Hochhausen, Holly Tasker, and Lynn Kirschbaum, present. Joseph Uppena and Tracy Fishnick, absent. The meeting had been properly called and convened and proper public notice given pursuant to Section 19.84 Wisconsin Statutes.
2. Consent Package
  - a. Approval of Minutes – A motion was made by Lynn Kirschbaum and seconded by Holly Mumm to approve the minutes from the October 27, 2025, regular board meeting. Voice vote: all present, yes. Motion carried.
  - b. Approval of Receipts and Disbursements – A motion was made by Holly Tasker and seconded by Jayson Hochhausen to approve the October 2025 receipts and the disbursements for October 23 - November 12, 2025. Voice vote: all present, yes. Motion carried.
